#### Here are some of the comments we received:


#### **GGUSD COMMITMENT TO STUDENT SUCCESS**

- Garden Grove Unified School District (GGUSD) students performed significantly higher than the state average on statewide exams
- A greater percentage of GGUSD students met rigorous college entrance requirements than other districts in the state or county
- GGUSD beat the county and state high school graduation rates

#### **PROPOSED SCHOOL FACILITIES IMPROVEMENT MEASURE**

To address school facilities needs and community priorities, the Board of Education is considering placing a \$311 million bond measure on the November 8, 2016, ballot. The repairs this measure would fund include:

- Heating and cooling infrastructure upgrades and air conditioning installation
- Building electrical system updates
- Seismic safety improvements
- Roof replacements
- Athletic stadium renovations and other athletic facilities improvements the district's stadiums and athletic facilities were built in 1958-1959 and have never been upgraded
- Classroom, science lab and instructional technology updates to support 21st-century instruction that prepares students for college and career success in competitive fields like science, engineering and technology

### **STRONG FISCAL ACCOUNTABILITY**

A local school improvement bond measure would include strict taxpayer protections:

- Every penny would benefit local schools and be controlled by the GGUSD Board of Education
- None of the funds could be taken away by the state or go to schools in other communities
- By law, no money could be used for administrator salaries
- Independent citizens' oversight and annual audits would be required to ensure funds are spent as promised
- The annual tax is estimated at \$34 per \$100,000 of assessed (not market) property value or approximately \$8 per month for the typical homeowner
