As the parent/guardian, after choosing a provider for academic support under NCLB Supplemental Educational Services, I understand that:

- The district is only obligated to pay up to the per pupil allocation, which is determined by the California Department of Education for the 2009 - 2010 school year, for the services. Services for my child will end when that amount is reached.
- Students who are eligible for Supplemental Educational Services (SES) must meet the following eligibility criteria:
 - Must attend a Program Improvement School (Year 2 or more)
 - Low socio-economic status as determined by Free and Reduced Lunch eligibility
- My child must regularly attend the program. If he/she is absent more than 3 times, my child may be dropped from the program.
- NO TRANSPORTATION is provided. Any transportation costs to and from the provider's location are my (the parent/guardian) responsibility.
- I must attend a meeting to establish academic goals for my child. I will receive a copy of this document.
- If I want to cancel service or change providers after tutoring has begun, I will notify the district office by writing. It may take up to 4 weeks before another provider is available, if funds are still available.
