A member of the audience may seek recognition to make an unwritten request to address the Committee on an agenda item under consideration by standing and waiting to be recognized. Recognition of such requests is at the discretion of the Chairperson. Upon recognition, the person should state his or her name and home address, and then direct comments to the Chairperson. Five minutes are normally allowed for each presentation. The Committee reserves the right to alter the time allowance when the number of recognized speakers warrants a change. The Chairperson may refer matters not appearing on the published agenda to the BOC coordinator for study and staff recommendations at a future meeting.
